### Welcome & Formalities

After a short finger food breakfast ShowCo President Paul de Schouwer opened at 9:05 h the Informal Member Meeting and welcomed all participants. This is an open Meeting, he stated. Guests are invited and present.

He appreciated very much the huge attendance of company representatives.

Then Mr de Schouwer asserted the formalities as follows:

- The invitation to this Meeting has been in compliance with the stipulations of our Bylaws,
- The Meeting could if necessary legal decide resolutions, because more than 20% of our members participate.



As usual Mr de Schouwer asked all participants of the Meeting,

to fill in their names, etc. in the circulating presence list, and

to deposit a *new* Business Card at the table. Klaus Fahlbusch will collect them later.

Then Mr de Schouwer asked all participants for a short self-introduction.

## <u>TOPIC 1</u>

## First impressions and experiences regarding the running trade fair.

ShowCo President de Schouwer opened the discussion regarding the running show. First reflections of the majority of the Meeting participants are positive. It was approved, that the organizer invested a lot of efforts, to make the exhibition attractive for visitors. Several Meeting participants stated a not too huge number of visitors, but a good quality of the visitors.

There were also a number of deficits identified:

The traffic in town is at all times a catastrophe; and the later more so. Later (by car) coming visitors lose a lot of time for nothing.

The complete trade fair has one final entrance door in hall 9 only. This has the effect, that exhibitors in hall 7 and hall 12 get their visitors relatively late. In those halls the first hour after opening is very quiet.

If visitors are not pre- registered (>25%), they can do it in hall 9 only. Furthermore all visitors have to collect their badges in hall 9. The whole procedure costs a lot of time; this time is lost for visitors and exhibitors. (Nobody can enter the halls without this procedure). It was reported, people give up to wait for registration, if they are able, to get otherwise a budge.

One company make a complaint regarding an unfair practice of the organizer, to allow sales promotion. Carpet inserts in the reception hall 9 were not offered official to all exhibitors, but one company only got the permission, to do it.

## <u>TOPIC 2</u>

## Short reports of the persons, who contacted Breeding- and Processing companies.

At our conference in Amsterdam (March 14<sup>th</sup> 2014) few persons with good contact to companies of the Breeding- and Processing- branch promised, to try for a dialog regarding ShowCo.

Mr de Schouwer asked if there are already first results.

Mr Mari van Gruijthuijsen reported regarding his discussion with Meyn. He is not very optimistic, because Meyn underlined its policy of independence. Neither our special offer regarding Atlanta, nor our South America project could change the Meyn position.

Not quite logical with view to the independence statement, the well-known argument "all or neither" came also. But this can be a chance, Mr van Gruijthuijsen said.

Prof. Rudolf Preisinger had a discussion with Aviagen. Mr Ted Seijnder was able to talk with Hendrix Genetics. In both cases no real progress regarding a ShowCo membership could be achieved. In the Breeding- branch not so much the independence argument, but especially the "all or neither"- principle seems to be important. This is very difficult, because the important companies have very different business interests (layer, broiler, turkey).

Mr Bernd Meerpohl recalled, that Atlanta could be no longer a problem, to join ShowCo. Without the Atlanta- problem he can't see a serious reason, to stay outside, he said. ShowCo is the only institution, who is a powerful counter weight against the trade fair organizers. There is no other possibility, to work successful for exhibitor interests.

In the following developed an intensive discussion between Mr Bernd Meerpohl and Mr Andy Miller (Linco Baader).

Mr Miller underlines for Linco Baader also the principle of independence. He justified this with very negative experiences in the past. Generally he appreciated the targets and actions of ShowCo, he said.

Mr Meerpohl accentuated also for all ShowCo members their independence. But this is not in contrast, to do logical things, he pointed out.

Mr Massimo Finco suggested, to ponder about a round table with few equipment companies and the important processing companies, to discuss the worldwide exhibition landscape and the interests of the industry in this regard.

Mr Andy Miller was open for this idea.

## TOPIC 3

#### Premium–Exhibition for South America.

ShowCo President Paul de Schouwer said, in view of the above-discussed situation we should not push this project at the moment too much. ShowCo in its actual size is not powerful enough, to establish alone such an ambitious undertaking.

Mr Massimo Finco reported regarding a talk, he has had with Dr. Javier César Prida. Mr Prida is President of CAPIA, Chamber of the Argentine Poultry Producers. Mr Prida and CAPIA are interested in a Premium Exhibition for South America. CAPIA is alone not able, to establish such a show. Therefore they are very interested in a cooperation with ShowCo in the matter.
